

## Fall Turkey Hunting Hours

Below is a map of the 2010 hunting-hour zones. Legal hunting hours (one-half hour before sunrise to one-half hour after sunset) for Time Zone A are printed below. To determine the opening (a.m.) or closing (p.m.) time for any day in another zone, add the minutes shown on the map for the zone to the time from the Time Zone A table.

The hunting hours listed in the table reflect Eastern Standard Time adjusted for daylight-savings time where appropriate. If you are hunting in Gogebic, Iron, Dickinson or Menominee counties (Central Standard Time), you must make an additional adjustment to the printed time by subtracting one hour.

## General Rules

**Hunting Hours**—It is unlawful to take or attempt to take a turkey except from one-half hour before local sunrise to one-half hour after local sunset. See the hunting hours in this digest.

**Bag Limit**—One turkey (any sex) per fall turkey license. It is unlawful to tag a turkey you did not kill, use a tag of another, use a tag more than once or allow another person to use your tag. Turkeys may not be taken while they are in a tree.

**Hunting Methods**—Hunters may use a bow and arrow, a crossbow, a firearm that fires a fixed shotgun shell or a muzzleloading shotgun for turkey hunting. It is illegal to use or carry afield any other firearm. The prohibition on carrying any other type of firearm does not apply to pistols carried under authority of a concealed pistol license or properly carried under authority of a specific exception from the requirement of a concealed pistol license. When taking wild turkey, a person shall not use or carry afield any ammunition except shotgun shells loaded with no. 4 or smaller shot or no. 4 or smaller loose shot for use in muzzleloading shotguns. You may hunt turkeys from an elevated stand or tree using a bow and arrow or crossbow. A free crossbow stamp, available from all license agents or online at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings), is required in addition to a valid hunting license for those using a crossbow to hunt. Turkeys may be hunted with dogs during the fall season. The use or possession of electronic devices that imitate wild turkey calls is illegal.

**Authority to Hunt**—Hunters may not hunt wild turkeys in any area or during any hunt period other than the area and hunt period designated on their license.

**Validating Kills**—Immediately upon killing a turkey, hunters must validate their license by notching out the appropriate information as instructed on the license and securely attaching the license around a leg of the bird. Hunters shall not have in their possession or transport a turkey unless the validated license is attached to a leg of the bird. Although not required, you are encouraged to report your harvest online at [www.michigan.gov/hunting](http://www.michigan.gov/hunting), under Wildlife Surveys and Reports.

**Baiting Prohibited**—It is unlawful to make use of bait to aid in the taking of a wild turkey. For the purpose of this regulation, "bait" means a substance composed of grain, fruit, vegetables or other food placed to lure or entice wild turkeys. This does not apply to standing farm crops (normal agricultural practices) or other naturally growing grains, fruits or vegetables.

**License**—The license is not valid unless signed by the licensee. Licenses cannot be altered or transferred. When hunting, you must carry your license and the identification used to purchase that license and exhibit both upon demand of a Michigan conservation officer, a tribal conservation officer or any law enforcement officer.

**Decoys**—Mechanical, electronic or live decoys are prohibited. Mechanical decoy means any device that, by design or construction, uses motion to attract a wild turkey, except a wind sock or similar decoy body anchored at a fixed point into the ground and whose only motion is derived exclusively by power of the natural wind.

## Recreational Trespass

This law requires permission from the landowner or lease holder before you may hunt on any farmlands or connected woodlots or on any fenced or posted private lands and prohibits discharge of a firearm within the right-of-way of public roads adjacent to these lands without permission of the landowner.

## Poachers Beware: Hunters are Watching

Violations of turkey hunting regulations, including application violations, are misdemeanors. Misdemeanors may be punishable by 5 to 90 days imprisonment, \$200 to \$1,000 fines and license revocation for up to three years. Reimbursement to the state for unlawful taking of a wild turkey is \$1,000 per animal. You can report all poaching by calling 800-292-7800.

## Authorizing Commercial Hunting Guides on State Land

The DNRE has determined that commercial hunting guides using state-owned lands require department oversight. Authorizing guiding activities on state land will be done in stages. In 2010, all commercial hunting guides utilizing state-owned lands must obtain a free Use Permit to help determine the scope and intensity of guiding. Public meetings will be held in 2010 to gather stakeholder input on the guidelines to be applied in the future. ## Mentoring: See the Difference It Makes

The fall wild turkey season offers the perfect setting for experienced turkey hunters to share their knowledge and skills with other hunters or introduce the sport to new hunters. Turkey hunting is a challenging, interactive activity, which is best shared with others. In addition to passing on the great tradition of our hunting heritage, turkey hunting in the fall also is a good opportunity to bring home a bird for a Thanksgiving Day feast. Get kids involved in this tradition. A youngster must be at least 10 years old by the time a license is purchased. So the next time you enter the turkey woods, be a mentor and see the difference it makes. If you plan to mentor an apprentice hunter, remember that you also must possess a valid 2010 fall turkey-hunting license. The license does not have to be for the same management unit or the same hunt dates.

## Apprentice Hunting License

A person who does not have a hunter-safety certificate may purchase an apprentice hunting license. An apprentice hunter may purchase this license for two license years before he or she must successfully complete a hunter-safety course. The apprentice hunting license is available to residents and nonresidents. Apprentice hunters under age 17, when afield, must be accompanied by a parent, guardian or someone 21 or older designated by their parent or guardian. This individual must possess a valid, regular hunting license to hunt the same game as the apprentice hunter. "Accompanied by" requires the adult to be able to come to the immediate aid of the other person and stay within a distance from the other person that permits uninterrupted, unaided visual and verbal contact. Apprentice hunters 17 and older, when afield, must be accompanied by someone 21 or older who possesses a valid, regular hunting license to hunt the same game as the apprentice hunter.

For hunting wild turkey, mentors of the apprentice need a valid turkey hunting license, but they do not need a permit for same hunt unit/period as the apprentice.

**A person may accompany no more than two apprentice hunters while hunting.**

## How to Obtain a Fall Turkey License

A limited number of hunting licenses are available in each fall turkey management unit. Licenses will be distributed first through an application and drawing; any licenses that remain after the drawing will be sold until the quota is met for each hunt unit. **Hunters may apply for the license drawing or wait to purchase a leftover license after the drawing, if available.**

## Application Information

- You may apply for the license drawing at a license agent, DNRE Operations Service Center or online at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings). It costs \$4 to apply.
- You will need one of the following forms of customer identification:
  - Valid Michigan driver license
  - State of Michigan ID card (issued by the Secretary of State)
  - DNRE Sportcard (issued through license agents or at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings))
- You must be at least 10 years old by the time a license is purchased.
- You may submit a single application only.
- You may apply in a partnership with one other person. The first applicant of each partnership chooses a hunt area and receives a party ID number. The other partner will need this number when applying to complete the partnership. Applicants who apply with more than one partner will be ineligible for the drawing.
- You are responsible for obtaining a DNRE application receipt that states your customer ID and hunt choice. Check this receipt for accuracy and retain as proof that you applied. Ensure that any application errors are corrected prior to the application deadline. Do not accept a DNRE receipt that is not legible.
- Applicants who submit an invalid application will be ineligible for the drawing.
- You are responsible for obtaining your drawing results online at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings).
- For application assistance, call 517-373-1263.

**IMPORTANT: It is your responsibility to check your application receipt for accuracy.**

## License Purchase

- If you are selected in the drawing or wish to purchase a leftover license, you may purchase your hunting license online at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings) or from any license agent.
- All licenses must be signed to be valid. Your signature on the license certifies that you meet applicable residency and hunter-safety requirements to purchase a Michigan hunting license.
- Make sure the information on your license is accurate.
- Licenses may not be altered or transferred.

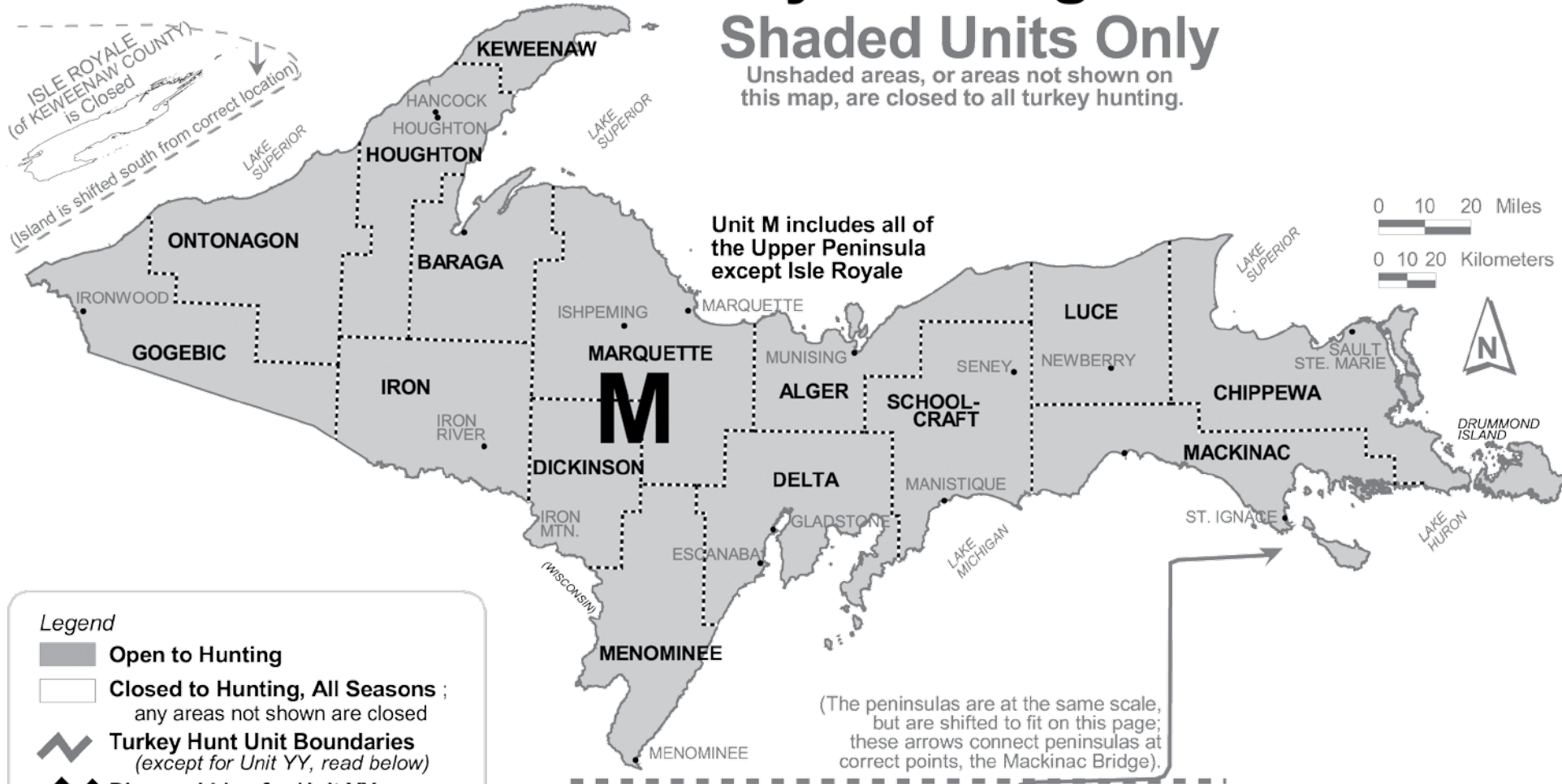

You do not have to harvest a turkey to purchase a patch. Send orders to the address above, and please make your check or money order payable to the National Wild Turkey Federation. The NWTf is a not-for-profit organization dedicated to the conservation of the American wild turkey and the preservation of the hunting tradition. Proceeds from patch sales are used to fund wild turkey-related projects and wildlife management in Michigan. Each year the NWTf, working cooperatively with the DNRE, contributes more than \$300,000 to wild turkey and hunter-heritage programs in Michigan.

2. Find the hunt number for the hunt unit you chose. You may make only one choice.
3. Complete worksheet.
4. Apply at a license agent, or online at [www.michigan.gov/huntdrawings](http://www.michigan.gov/huntdrawings).
5. It is unlawful to apply more than once.
6. Check your application receipt. Retain receipt as proof of application.

Hunters may apply for a turkey license or wait to purchase a leftover license after the drawing, if available. Licenses will be sold until the quota is met for each hunt unit. There is no guarantee leftover licenses will be available in any hunt unit.

NOTE: It is unlawful to apply for more than one turkey license. If you are selected in the drawing, your drawing success authorizes you to purchase only one turkey license. This does not preclude you from purchasing remaining licenses after the drawing, if available.

### Unit YY (Hunt Number 501)

Fall hunt unit YY encompasses only private lands in southern Michigan and on Beaver Island. Licenses for unit YY will be sold over the counter and may be purchased when leftover licenses are available for purchase, as explained below. **No application is required.**

### Leftover Licenses

There is no guarantee that leftover licenses will be available for any hunt unit. If any licenses remain after the drawing, unsuccessful applicants may purchase one leftover license online or from any license agent on a first come, first served basis for a one-week period beginning August 23 at 10 a.m. EDT. Any limited-quota fall turkey licenses that remain as of August 30 at 10 a.m. EDT may be purchased by any hunter, including those who did not apply for a fall turkey license. A hunter may purchase one license per day until quotas are met.

### 2010 Fall Workshop Dates

The DNRE, National Wild Turkey Federation (NWTf) and other groups are cooperating to offer wild turkey-hunter orientation courses. The training sessions are open to anyone and may include turkey-hunting methods, calling, regulations and population status.

### Dioxin Advisory Information

Health assessors from the Michigan Department of Community Health (MDCH) and Michigan Department of Natural Resources and Environment determined that samples of wild game taken in 2003, 2004 and 2007 from the floodplains of the Tittabawassee River and Saginaw River downstream of Midland contain high levels of dioxin and dioxin-like compounds. Wild game that have been tested include deer, turkey, cottontail rabbit, squirrel, wood duck and Canada goose. As a result, the MDCH advises that hunters and their families follow these recommendations related to turkey:

- Do not eat turkey harvested in or near the floodplain of the Tittabawassee River downstream of Midland. If you choose to eat turkey taken from this area anyway, at a minimum the skin, liver and gizzard should be removed and discarded.
- Other wild game that have not been tested in this area may also contain dioxins at levels that are a concern. To reduce general dioxin exposure from other wild game, trim any visible fat from the meat before cooking, do not consume organ meats such as the liver or brains, and do not eat the skin.

As a reminder, Fish Consumption Advisories remain in effect for sport-caught fish from the Tittabawassee River south of Midland, the Saginaw River and the Saginaw Bay based on levels of dioxin and polychlorinated biphenyls. If you eat several different kinds of wild game as well as fish from the areas covered by the Wild Game and Fish Consumption Advisories, MDCH recommends that you eat these foods less often than suggested here to reduce your exposure to dioxin.

### Wild Turkey Hunting Tips, Ethics and Safety

A key component of successful fall turkey hunting is locating birds. Good areas for sighting flocks include idle fields, woodlands and around logging trails. Scout for tracks, fresh droppings and feathers.

Locate a good food source, around which birds are congregating – in the fall, for instance, turkeys feed on insects and mast crops like acorns – and learn the habits of the birds. Listen for the sounds of birds scratching in the leaves or for their "flock talk" as they come and go to roost. Roosting flocks may produce a wide variety of yelps, clucks, "kee-kees" and gobbles.

Once you have located a flock, one hunting tactic is to scatter the flock. Approach the flock within 50 yards and flush the birds so they will scatter. A dispersed flock normally will begin to regroup near the original point of separation within 15 to 30 minutes. Quickly set up at this spot and, as the flock begins to reassemble, begin calling the turkeys by imitating the same sounds they make. Answer every turkey call you hear with similar tone, pitch and rhythm. Using a decoy also may help fool birds into approaching your location.

Successful hunters sit still and allow the birds to come to them. Because a turkey can detect and react to movement 10 times faster than a human, movement is a turkey hunter's greatest enemy. And remember that camouflage does not make you invisible – even though camouflaged, you are still an unnatural form in the woods that birds will notice.

Do not attempt to stalk a turkey. Your chances of success are poor and, at best, you might get a glimpse of tail feathers. More importantly, that gobbler or hen you are stalking may turn out to be another hunter, a potentially dangerous situation. Many turkey hunters are very convincing callers, so assume that another person is making every sound you hear and always keep a safe distance. If another hunter is working a flock, give that person the same respect that you would expect and do not interfere by calling or spooking the birds.

Do not jump and turn at a turkey approaching from behind. The chance of getting a good shot is very slim. Instead be patient, remain still and let the bird pass.

Know the capabilities of your gun or bow and use it safely. Be positive of your target, make sure the bird is within range, and shoot at the neck and head only.
